Liability Release

As a patron of A Different View Equine Center, I acknowledge the risk and potential for risk, including but not limited to: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) the unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) hazards, including, but not limited to surface or subsurface conditions; (d) a collision with another equine, another animal, a person, or an object; (e) the potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person or the participant or to other persons, including, but not limited to failing to maintain control over an equine or failing to act within the ability of the participant (f) any injury from work environment or equipment.

However, I feel that the possible benefits to myself and to the participants I work with are greater than the risk assumed. I hereby, intending to be legally bound, for myself, my heirs, and my assigns, executors or administrators, waive and release forever all claims for damages against A Different View Equine Center, its Board of Directors, Instructors, Employees, Therapists, Aides and Volunteers from any and all injuries and/or losses I may sustain while participating in A Different View Equine Center's activities. I acknowledge that I am fully responsible for myself and any minors I have in my care in any event that medical attention is needed. In the event that I, as an adult, am unable to make medical or any decisions I agree that the staff at A Different View is to contact emergency services immediately on my behalf. I am responsible for medical decisions for any minors that are participating with me at ADVEC.

Barn Rules

1. ALL visitors (Veterans, 1st Responders, participants and volunteers) MUST sign in and out for every visit. Sign in sheet is in the office (due to COVID it will be digital format updated by staff)
2. If you come to the property without management please STOP and contact one immediately.
3. Liability forms must be signed by every visitor/volunteer/participant before work or any activities can begin. These are good for one year unless rules/regulations are updated. At that point new forms will be completed/updated. Effective 4/2020 additional COVID/general health precaution waivers must be signed and updated yearly.
4. Horses are not to be handled, worked, walked or ridden without Board approved staff/ management present.
5. You may pet the animals, however, NO ONE is allowed to go into *any* pasture, paddock, stall or gate without permission from a management personnel, this permission needs to be approved EVERY time you are here. Permission is given on a day by day basis.
6. Clean up after yourselves, leave the farm better than you found it.
7. NO Smoking or Alcohol EVER on the property including in a personal vehicle
8. NO Firearms
9. No open toed shoes
10. Helmets are to be worn at all times by ALL riders
11. Foul language will not be tolerated
12. Respect each other as well as all the animals at all times!
13. If you see something that needs to be addressed, please address management right away!

We reserve the right to refuse service to anyone. If you do not follow these rules you will be asked to leave the property. These rules are for the health and safety of our animals, veterans, 1st responders and volunteers.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

A Different View Equine Center (“ADVEC”) has put in place preventative measures to reduce the spread of COVID-19; however, ADVEC **cannot guarantee** that you or your family will not become infected with COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself and my family (including, but not limited to, personal injury disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my family may experience or incur in connection with myself or family’s attendance at ADVEC or participation in ADVEC activities and events (“Claims”). On my behalf, and on the behalf of my family, I hereby release, covenant not to sue, discharge, and hold harmless ADVEC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of ADVEC its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation at ADVEC.

Covid-19 Protocol and Agreement

I/We agree:

1. To wear a mask when within 6 feet of another person and wash hands frequently.
2. If you are feeling ill (Cough, fever, or any other symptoms) or anyone in your home is, please stay home. If you are unsure if your symptoms make it unsafe to come please discuss with the staff via call/text prior to arriving.
3. If you are waiting for a Covid test result, or have been in contact with a positive patient, please stay home until a negative result, required quarantine time has passed and are cleared by your doctor.
4. I/we understand, as a safety precaution surfaces that are touched will be sprayed down by staff or volunteers with a 10 percent bleach solution between clients, volunteers, and staff usage.

CONFIDENTIALITY AGREEMENT

A Different View Equine Center (“ADVEC”) adheres to extremely strict confidentiality standards and maintains confidentiality about any and all participation at the farm and any information disclosed in any activities, with the following exceptions for equine facilitated learning sessions (EFL). In an effort to provide the participant with the best service in our EFL program, information may be shared with other EFL clinicians for consultation or for supervision purposes. All requests for information about equine-facilitated activity sessions to be shared with another provider, agency, or primary therapist/counselor/psychotherapist, must be made in writing.

Due to the nature of ADVEC services, participant population, and possible situations and discussions that may arise *it is the responsibility of all participants to hold all proceedings that do not belong to one's personal experience confidential.* We respect all those who choose to talk and discuss difficult topics and be a part of all what ADVEC has to offer. It is our duty, as fellow participants, to hold the same respect and privacy of all participants at ADVEC. It is our priority to hold a safe space for all participants whether they are present or not.

All staff at ADVEC hold a legal obligation to disclose confidential participant information, even without consent, in the following situations:

Emergency: If the participant is involved in a life-threatening emergency and permission cannot be obtained, information will be shared if it is believed the participant would have wanted it to be done or if it is believed it would be helpful to the participant. **Child Abuse Reporting:** If there is reason to suspect that a child is abused or neglected, it is required by law to report the matter immediately to the Department of Social Services/Child Protective Services. **Adult Abuse Reporting:** If there is reason to suspect that an elderly or incapacitated adult is abused, neglected, or exploited, it is required by law to immediately make a report and provide relevant information to the Department of Welfare or Social Services/Adult protective services. **Serious Threat to Health or Safety:** If the participant discloses a specific and immediate threat to cause serious bodily injury or death, to an identified or to an identifiable person, and there is belief that the participant has the intent and ability to carry out that threat immediately or imminently, it is legally required to take steps to protect third parties. These may include (1) warning the potential victim(s) or the parent or guardian of the potential victim(s) if under 18; (2) notify a law enforcement officer; or (3) seeking participant's hospitalization.

A Different View Equine Center definition of “participant”:

Anyone who comes to the facility at 500 E Steeplechase Rd, Pleasant Garden NC is defined as but not limited to:

- Staff and any approved visitors they bring
- Volunteers
- Veterans, 1st responders their families and caregivers
- EFL, participation or inquiry
- Fishing and any guest of
- On site drop off or presentation of donation whether monetary or tangible
- Maintenance, either as volunteer or paid
- Landowners and family of leased property
- Board members
- Any person(s) providing medical care

All participants at ADVEC are required to respect, uphold and sign the confidentiality policy.

We will maintain your privacy and expect you do the same of any other participants you may encounter here at ADVEC. PLEASE feel free to tell your friends and family about your experience! Shout it out loud for all to hear!!! We cannot say a word about the amazing things that happen for you personally, but YOU CAN if you feel comfortable and we absolutely LOVE THAT!!! This agreement says you will uphold the rule to make sure you only talk about your own experience and not anything about any other participants no matter how small or insignificant it may seem.
